In either case, size of the HPC should be with Theoretical Peak >=27 TF CPU.
- 3. Vendor having well established service and support facility at Ahmedabad/Gandhinagar will be preferred.
- 4. Vendor should submit office address proof.

#### Scope of work:

- 1. Software support as per Appendix-1 is required for ITEMs listed in Appendix-2.
- 2. Vendor will solve software related issues either by remote support or by sending their engineer onsite in co-ordination with OEM (as and when required) and IPR HPC team.
- 3. Other activities in software support will include installation of MPI libraries, commercial scientific/Math libraries, C, C++, GCC, Fortran, Python, Java, CUDA etc., compliers, parallel debugger, profiling tool, patch update etc., as and when required.
- 4. Vendor will be responsible for fresh installation (if required) in case of any failure.
- Installation/implementation/upgrade of any hardware/firmware, BIOS, patches, if required.
- 6. Part replacement as and when required will be done by vendor without cost to IPR.
